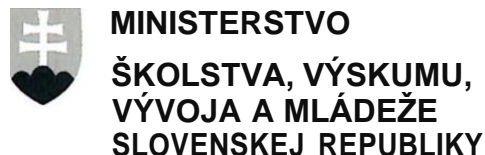
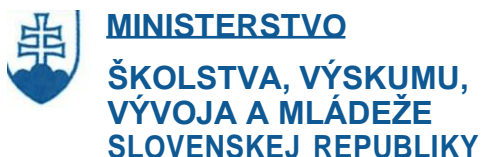

In this regard, it is essential to approach its promotion accordingly.

When promoting, it is required to use the full name of the ministry, specifically "Ministry of Education, Research, Development, and Youth of the Slovak Republic."

After the patronage is granted, the organizer is required to place the logo of the Ministry of Education, Research, Development, and Youth of the Slovak Republic in an appropriate size and location for representational and promotional purposes.
